## REGULAR MEETING OF THE KIMBERLY VILLAGE BOARD MINUTES AUGUST 30, 2021

Jennifer Weyenberg was welcomed as the newly appointed Village Clerk-Treasurer and was administered the Oath of Office by Finance Manager Rein.

Trustee Hammen moved, Weber seconded the motion to approve Resolution 5, Series of 2021, a resolution changing the bond requirement for certain Village officials. The motion carried by unanimous vote of the Board.

Trustee Hammen moved, Weber seconded the motion to approve Change Order #1 for the 2021 Sewer Cleaning & Televising | Area 1 project, (McM. No. K0001-9-21-00266), to Green Bay Pipe & TV in the amount of -\$3,573.12 (decrease). The motion carried by unanimous vote of the Board.

Trustee Hammen moved, Trentlage seconded the motion to approve payment of Certificate for Payment # 1 for the Railroad Street Concrete Multi-Modal Trail project (McM. No. K0001-9-21-00271) to Vinton Construction Co. in the amount of \$184,911.13. The motion carried by unanimous vote of the Board.

Trustee Trentlage moved, Hammen seconded the motion to approve payment of Certificate for Payment # 1 for the Eisenhower Drive Street Reconstruction project (McM. No. K0001-9-20-00811) to Vinton Construction Co. in the amount of \$299,194.47. The motion carried by unanimous vote of the Board.

Trustee Hammen moved, Weber seconded the motion to approve the proposed revision to the Village of Kimberly Infrastructure Standards & Special Assessment Policy. The motion carried by unanimous vote of the Board.

Trustee Hammen moved, Gaffney seconded the motion to move into Closed Session pursuant to Wis.
