EXPLANATION:

At the November 13, 2023 Village Board meeting, the analysis and findings of the Value Engineering Exercise were presented. Staff are now bringing the item forward for consideration.

Staff are providing supplemental information for consideration through the following attachments:

- 1. Itemized/more detailed list of project costs. Please note that the cost savings presented at the 11/13/23 meeting for Furniture/Fixtures/Equipment are reflected.
- 2. The Village Attorney has provided his analysis of the design-builder question. In sum, it is not allowed per the state statutes regarding public bidding for public works projects; nor is there an exemption for this type of project under other statutes.
- 3. Itemized list of Value Engineering Cost Savings Options for consideration.

A table is provided with options identified by letter (A-J) and includes the net savings, impact on schedule and staff recommendation. Note, these options can be selected individually by line-item (with exception of Option B metal roof which is dependent on Option A metal building) and the schedule extension is not cumulative—20 weeks is the longest possible time extension no matter how many/which options are selected.

Staff recommended cost savings summary:

- (F) \$29,665 savings to remove Outdoor Site Amenities, 2 week schedule extension
- (H) \$43,500 savings to remove PA system, 2 week schedule extension
- (J) \$136,695 savings to remove concrete at truck doors, 2 week schedule extension

\$209,860 Total estimated cost savings and 2 week schedule extension

RECOMMENDED ACTION: Staff prefers no changes to the design; however, should cost saving be considered, we recommend any combination of options F, H, and J (as detailed above).

Re: Legal Opinion on using one vendor for design-build projects

Per Attorney Koehler on 11/14/23:

Public Bidding for Public Works in Village is governed by section 61.54 and 66.0901 (1m)(a) Wis. Stats.

- Section 61.54 adopts by reference the procedures applicable to cities for bidding in 62.5
 Wis. Stats.
- Section 62.15 "Public Works" (1) requires all public works contracts for an estimated costs over \$25,000 to be publicly bid.
- Section 66.0901 (1m) (a) requires the sealed bid process, and awarding the bid to the "lowest responsible bidder", which is also a requirement in 62.15 (1) Wis. Stats.
- There is an exception for public bidding for village and cities if all the materials are donated or if the labor for the project is provided by volunteers.

"Design services" have traditionally not been considered "Public Works" subject to bidding, but it has been my experience that the construction work cannot be combined with design services to avoid the public bidding requirement.

The public policy behind public bidding is protection of the tax payers funds, avoidance of favoritism, fraud, etc. Circumvention of this protection by combining construction work with design services would probably run afoul a public policy in the eyes of the court absent a specific statutory or court created exception which I am not aware of at this time.

Attorney Koehler provided the following supplemental information on 11/16/23 in response to a request to also look at WS 13.48 (19) or WI Act 58 (2017) and their relevance to this question:

Section 13.48 Wis Stats created a State "Building Commission" consisting of the Governor, 3 senators and 3 representatives from the County. It appears to me that section 13.48 entitled long-range public building program applies to state buildings.

- Section 13.48 (19) allows for alternative contracting procedures if approved by the state Building Commission.
- Section 13.48 (2)(b) 2. Refers to construction of new buildings or additions used for housing Sate offices and for general State purposes.
- 13.48 (19) gives the building commission authority to waive certain procedures when it is in the best interest of the State and approved by the Building Commission.

Wisconsin Act 58 (2017) Amended section 61.57 entitled "Acquisition of Facilities without bids" but only for certain projects including:

- 1) A recycling or resource recovery facility.
- 2) If the village contains an electronics and information technology manufacturing zone that is designated under s. 238.396 (1m):
 - a. Water and sewer systems.
 - b. Wastewater treatment facilities.

I looked at this statute before issuing my memo but didn't include it because the streets and park facility project didn't fit any of the exemption categories under 61.57.
